### **CIRCULAR:**

Sub:- Payment of Scrutiny Fees, Revalidation Charges & Charges of Summary Eviction Action u/s 95(A) of MHAD Act for Redevelopment Schemes under DCR 33(7), 33(9) & 33(6).

The Redevelopment of old & Dilapidated Cess Building in the Island City of Mumbai is carried out as per the Provisions of DC Regulation 33(7), 33(9) & 33(6), amended from time to time by Govt. in UD Department vide Notification published in Govt. Gazette dated 25th January 1999, Notification No.TPB 4308/3224/CR-268/08/UD-11 dated 02nd March 2009 Notification No.TPB 4308/3224/CR-268/2008/A/UD-11 dated 21st May 2011, No.TPB-4312/CR-5/2012/UD-11, dated 14.08.2013, Notification No.TPB 4317/629/CR-118(III)/2017/EP(DCPR)/UD-11 dated 21 September 2018 & Notification No.TPB 4317/629/CR-118(III)/UD-11, dated 12 November 2018, Notification No.TPB-4320/107/CR-72/2020(Part-I)/UD-11 dated 08.07.2021 and Ministry Of Environment, Forests And Climate Change's Notification dated 16.06.2015.

It is observed in some cases that, after obtaining NOC for redevelopment from MBRRB, the Owners / Developers are not starting the Schemes within timeframe mentioned in the NOC conditions due to which the tenants/ occupants are deprived of their rights of getting possession of their new rehab tenements.

In order to expedite the redevelopment schemes & complete the same within stipulated time period & considering the man power / staff required to process the proposals, the Scrutiny Fees & Revalidation Charges are now revised as under:-

c. The NOC granted by MBRRB is valid for 01 year from date of issue of NOC. As per the conditions of NOC, the NOC holder is required to submit proposed plans to MCGM for approval within 06 months & obtain approval to IOD/Plans & Commencement Certificate from MCGM and start the work within a period of 12 months from the date of issue of NOC. Further after obtaining Commencement Certificate, the work of redevelopment is to be completed within a period of 36 months. Hence, Revalidation charges in such cases shall be as under:-

NOTE:- For 2b & 2c above Online Portal shall be created by the NOC holders/
Developers for all the NOCs within a period of 30 days. The NOC holder
will submit self certified Revalidation letter on Online Portal & the
payment of Revalidation Charges shall be paid online to MBRRB
Payments Services available on MHADA website
(https://www.mhada.gov.in). The application & Revalidation charges
shall be made by the NOC holder/Developer on or before expiry of
Validity of NOC every year. If the NOC holder/Developer fails to do so

then the Revalidation Charges will have to be paid 05 times of charges mentioned in the "Table-C" above. Till creation of online portal the procedure followed by MBRRB shall be continued.
